

ESPHS MEMBERS TAKE NOTE:
EXHIBITS NEEDED FOR JUNE COMPETITION
AT COLOPEX 2013 IN COLUMBUS OHIO

After a one-year layoff, the Charles H. Sweeting Postal History exhibiting competition between the postal history/state philatelic societies of the six New England states plus NY, NJ, PA and OH will resume June 7-9 at COLOPEX 2013, the annual WSP show sponsored by the Columbus OH Philatelic Society.

Often referred to as the Northeastern Multi-State Postal History Exhibiting Competition, the winning society has its name and the venue of its victory engraved on a plate attached to the Charles H. Sweeting Memorial Award and gets possession of the 14x20 inch Award plaque until the next competition is held.

The competition has to be held at a World Series of Philately show within the competing ten states. The most recent competition was held at ROPEX 2011 with ESPHS winning. There have been six competitions for the Sweeting Award with the first at ROPEX 2004, and all but one (COLOPEX) of the seven eligible WSP shows has held a competition.

Although by winning at ROPEX 2011 ESPHS could have hosted the 2013 competition as well, it instead deferred to the Ohio Postal History Society so that society could host the next competition at COLOPEX and thus bring in the one remaining eligible WSP show yet to hold a competition.

Scoring for the competition is based on medal levels awarded the exhibits, and all medal levels contribute to the total team score. **Thus new postal history exhibitors belonging to one of the competing societies are not only welcome, but strongly encouraged to enter.**

Exhibits qualifying for the competition do not have to be postal history exhibits of the State of the Society to which the exhibitor belongs. As long as the exhibitor belongs to one of the competing societies, he/she can exhibit postal history generally, postal history of a U.S. stamp or stamp series, or even illustrated mail so long as it relates primarily to a single state.

ADVERTISING COVERS SHOW AREA'S GROWTH

During the latter nineteenth and the early twentieth centuries advertising covers were widely used by those having merchandise or services to sell, messages to convey or ideas to promote. A collection of these covers is an ideal way for anyone interested in the development of an area to follow its history, such as my hometown — Watertown.

This Jefferson County city once was a busy hub of numerous industries, including paper mills and the manufacture of sewing machines, carriages, and automobiles.

Davis Sewing Machine Company was founded in 1868 to manufacture an improved machine, invented by Job Davis, shown on the cover mailed from Clayton in 1882 (top left). The company moved to Dayton, Ohio, in 1889 and later, under a different name and ownership, built Huffy bicycles and power lawn mowers before moving to Mexico.

H. H. Babcock Company was founded in 1845 to build wooden pumps and underground wooden water pipe. It later made windmills and iron pumps shown on the 1882 cover (top right). Before closing in 1928, it built automobiles and pickup and delivery trucks.

The D. S. Brown Company made horse collars and harnesses. The cover at the lower left was mailed in 1915 by a dealer in Depauville. The Neverslip Tin Cover Co. envelope was mailed in 1901. Although manufacturing is still carried on in Watertown, horse collars and tin covers are no longer made there. As the fellow once said: "progress happens." ■

ALBANY LINCOLN AND STARS CANCEL



Editor's Note: This article was originally published in U. S. Cancellation Club NEWS, November 2012 edition. By kind permission of the publisher and the author we are pleased to reprint it here in full. Please read my afterword in which ESPHS asks that each member who is fortunate enough to own (or know of) one or more examples of the Albany "Lincoln and Stars" cancel respond to Ernie Webb's request for census data.



In the February 2012 *NEWS* I posted a "help wanted" request for information regarding the 1860s cancel used by the Albany, New York post office illustrated herewith. The purpose of this article is to report what I have learned in the intervening months. Eighteen covers or pieces have now been recorded with only two providing documentation of the year of use. See Table 1 on page 3.

Out of 18 covers and pieces found, one has an enclosure dated 1865 and one is back stamped with 1865 as a year date. Now it is hardly scientific but I feel pretty certain the year of use must be 1865. George Dawson was Albany's Postmaster from March 27th 1861 to August 3, 1866 and was an ardent pro Republican of the time and presumably the postmaster using the Lincoln cancel. The Lincoln and stars cancellation has only been found on Sc 65 and Sc 78 (with one example on an off cover Sc 73). It has 13 stars which probably represent the original 13 states. The cancellation began its use just 5 1/2 months after the Lincoln assassination and appears to have been only used for about one month, October 1 through October 22, perhaps making it even rarer than the famous Devil and Pitchfork cancellation of West Meriden, Ct, in use April 16th through August 31st 1866.



Many questions still remain unanswered, such as why it was produced, what was happening in Albany at the time to prompt the design, and why was it used only for a short period, etc., plus many other questions yet unmentioned.

I want to personally thank all the members who responded with input and photos especially Abe Boyarsky, Don Barany, and George McGowan just to mention a few. Editor's note: Matt Kewriga pointed out that Albany used another distinctive patriotic cancel design in October 1865. See the cover shown herewith, postmarked October 9. It can be year dated 1865. Actually, Albany used several variations of this design—see Skinner/Eno PT-C 17 through 20 and Whitfield 5056-8. A similar Albany cancel, but involving "USA" in the center, is also known—see S/E PT-USA 1 through 2a. We don't have dates of use for these and if readers can supply any, please contact the *NEWS*. From the tracings, it appears that all cancels show 13 stars.

AN OPEN LETTER TO THE MEMBERSHIP OF ESPHS:

First of all, I want to thank all of you that have known me during the time I have been a member of the Empire State Postal History Society. This includes, but it certainly not limited to, all the customers who have made my company, Excelsior Postal History, a modest success. (No, the name wasn't taken from the NY State motto).

It would be an egregious error not to mention the wonderful friends made and the added enjoyment in the pursuit of Postal History. Even though my personal preference is for Western New York State, learning from collectors of the "other counties" has been a pleasure. I am concerned about future opportunities.

There will be no surprises when the average age of the membership is stated as "older," for lack of a kinder term. Where are the new members going to come from? Are we to depend on the American Philatelic Society for new members? That organization is in decline and will suffer the same fate as ESPHS if nothing is done.

When I joined ESPHS in December 1983, I was only 26 years old. That was a very young age to be a member of any postal history group. When was the last time we had a new member that young? Even if there were several, are there enough new serious postal historians to guide this organization into the future?

Many of you know that I served in the United State Air Force for a number of years. In my travels, it was noted that people who might be bored by, or completely uninterested in stamps can show great interest when the subject of their hometown is discussed. From this source, there is marked potential to find new members. They don't have to be collectors, either.

Another area is mentorship. My knowledge of the counties I collect has grown over the years, and many people who shared their knowledge with me are gone. Who can I pass my knowledge on to? Have you given any thought to this? There is obviously a consideration in having new people start to collect a county. We all would prefer to have someone interested in our collecting area when it comes to the disposal of our collections. Please don't let potential competition limit your vision or otherwise keep you from trying to teach younger people about postal history or what ESPHS was founded for and has to offer.
